REAL TIME DOCKETING & SCANNING (RTDS) STAFF GETS MUCH DESERVED RECOGNITION!

The RTDS Staff recently received a Team Recognition Award from the Administrative Office of the Probate & Family Court! The following article appeared in the Probate & Family Court's Newsletter, *Family Matters*.

Real Time Docketing and Scanning is a pilot program which began in January of 2016. This program was facilitated by Register Gina L. DeRossi with the assistance of Operations Supervisor Matthew Abraham, who served as the RTDS Coordinator.

Under the pilot, data is docketed directly into MassCourts and then the accompanying images are scanned during the courtroom session. The pilot process ensures documents filed or issued at a hearing are immediately available for access.
