### ***E-FILE Status in BRISTOL COUNTY!***

#### **First official E-File Training in Bristol County is a SUCCESS!**

Effective April 3rd, the Bristol County Probate & Family Court began accepting Formal and Informal Probates as well as 1B Divorces via E-File. In April, Register DeRossi hosted an E-File Training Program for Attorneys and their support staff to provide introduction and basic instruction on the purpose and use of E-Filing. The event was attended by over 75 attorneys and support staff. Representatives from Tyler Technologies gave a presentation about the system and the future of E-Filing in our courts.

To date, Bristol County participation in the E-File Pilot has exceeded that of all other participating Probate & Family Court Divisions.
